Motion 217-19 Resolution Deeming Impractical Transportation

WHEREAS, resident students in grades kindergarten through eight, who reside two miles or more from their non-public school of attendance, outside the Reading School District are declared by Section 3327.01 of the Ohio Revised Code and State Board of Education Standard EDb 9-17002(d) to be eligible for transportation; and

WHEREAS, an examination of existing bus routes, time schedules, student residence location, school location, and available school conveyances has been conducted; and

WHEREAS, such examination has revealed that the transportation of certain students is impractical to the District: therefore

BE IT FURTHER RESOLVED that the District shall provide payments in lieu of transportation to the parents of the students listed herein consistent with Ohio Revised Code Section 3327.02. Such payment shall be the amount received for reimbursement by the Ohio Department of Education except that in no case will the payment be amount less than the amount determined by the Department as the minimum for payment in lieu of transportation, and not more than the amount determined by the Department as the average cost of pupil transportation for the previous school year. Payment may be prorated if the time period involved is only a part of the school year.

BE IT FURTHER RESOLVED that payment by the Board of Education is conditional upon the availability of State funds for the purpose of providing pupil transportation and that this resolution shall be applicable to the 2019-2020 school year only.

BE IT FURTHER RESOLVED that the Board of Education hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Board of Education, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect from and immediately after its adoption and shall supersede any prior resolution or act of this Board of Education which may be inconsistent with or duplicative of the provisions of this resolution.
