

READING BOARD OF EDUCATION Regular Board Meeting August 5, 2020

The Board of Education of the Reading Community City School District met in Special Session at Reading Community City School, 810 East Columbia Avenue on August 5, 2020, at 5:30 p.m. Due to COVID-19 restrictions these meetings are being lived streamed on RCCSD YouTube channel.

The meeting was called to order by the Board President, Beth Wernery at 5:30 p.m.

Board Discussion Items

- A. Hilltop Property Mr. Evan Kelsey provided a brief overview of the four options the building and grounds committee discussed. Ms. Alycia Bemmes provided additional information regarding why option 1 and option 4 were ultimately the best option. In addition, Ms. Colette Lewis mentioned that the funding for this project will not come from the general fund but would come from the remaining funds from the Certification of Participation taken out in 2012. The district currently has approximately \$950,000 in this fund.
- B. Construction Updated Mr. Evan Kelsey also provided an update on the construction and finalizing the project. The District, Shook, and VSWC will be working on completing the punch out list. Shook provided a deadline of August 12th to the subcontractors and VSWC will back punch the list.
- C. Utility Poles Ms. Colette Lewis stated that our response to the law suit was filed and Mr. Bill Deters has not received any communication back from the court.
- D. Superintendent/Treasure Evaluation Ms. Beth Wernery will work with Mr. Jason Enix and Ms. Colette Lewis to coordinate a plan for future evaluations.

Superintendent Report

- A. <u>Reopening Plan</u> Mr. Jason Enix provided an update on the 2020-2021 school reopening plan.
- B. <u>Board Policy 1st Reading</u> Policy 5200 – Attendance Policy 8450.01 – Facial Covering During Pandemic/Epidemic Events Policy 3220 – OTES 2.0 Standard-Based Teacher Evaluation

Treasurer Report

- A. Five Year Forecast Ms. Colette Lewis will be attending two sessions over the next few weeks to get the forecast ready for the November submission.
- B. Student Wellness Funds The funds will be spent on the new K-5 position for wellness, district wellness coordinator, and curriculum to support these programs. The remaining funds will be used for the counselor. The update from the State shows a reduction of ~\$81,000 of expected funds.
- C. Cares Act Ms. Becky Johnson and Ms. Colette Lewis are working with SPPA and MND to allocate the funds that are due to them. The district has decided to use the calculation of total enrollment determined



ODE. This calculation provides the most funds to the nonpublic schools in Reading and more flexibility for MND, SPPA, and RCCSD. RCCSD plans to use these funds for the Clinical Clerical Aide, additional cleaning support, and personal protective equipment.

D. Broadband Ohio Connectivity Grant – RCCSD will be able to apply for this grant starting August 10. This grant will allow us to be able to provide additional support for the remote learners.
