Motion 200-20 Approve Agenda

- A. Financial Overview Ms. Colette Lewis gave a brief overview of the district financials.
- B. Maintenance Planning Mr. Jason Enix provided an update on a second option for a maintenance plan
- from Four Seasons and compared the two options provided by both Omnia 360 and Four Seasons. C. Construction Update
  - New Building: Mr. Jason Enix and Ms. Colette Lewis provide an overview of what is upcoming. Ms. Colette Lewis called a meeting to walk through the entire punch out list with VSWC and Shook.
  - b. Chiller Noise: Is still an issue. The District is partnering with VSWC to hire a sound engineer to provide additional options to help mitigate some of the sound. This is scheduled for September 9<sup>th</sup>.
  - c. Fence Line Neighbors: Mr. Jason Enix, Ms. Colette Lewis, and VSWC will be meeting with Thurnridge residents virtually on September 28<sup>th</sup> to review issues regarding the chiller and fence.
  - d. Central Property: Mr. Jason Enix and Ms. Colette Lewis received confirmation from Mr. Patrick Ross that turning the Bonnell property into an entire green space will not be problematic with the city.
  - e. Hilltop Property: VSWC, Mr. Jason Enix, and Ms. Colette Lewis visited Hilltop on 8/29 to discuss the baseball and softball complex. Continuation of the board approved plan will take place on 9/9.
- D. Strategic Plan: Interviews are scheduled with Dynamix and Hamilton County ESC to help determine the next phase of a strategic plan for the district. The District is looking to have the interviews completed on 9/10 and the development and completion of the strategic plan in December 2020.
- E. Kindergarten Enrollment Policy: Mr. Jason Enix recapped the presentation presented to the board on January 22, 2020. Board Discussion regarding next steps and additional information was requested.
- F. Superintendent/Treasurer Evaluations: Mr. Jason Enix, Ms. Colette Lewis, Ms. Beth Wernery, and Ms. Crystal Menner will meet to put together a plan on the evaluations process
