Hamilton County COVID-19 Reporting

October 2 HCPH Update (with county superintendents)

- R Factor 1.09 (up from 0.84 week before)
- Hospitalizations 9 per 100,000 people
- Improved positivity rate in 18-24 year old bracket 7%
- Shift from Level 2 (Orange) to Level 3 (Red) on October 1 Now at 4 metrics:
 - New cases per capita (90.2 per 100,000); consistently flagged
 - Proportion of cases not in congregate setting; consistently flagged
 - Sustained increase in outpatient visits (102.3 avg visits 9/9 to 192.0 9/27)
 - Sustained increase in hospital admissions (1.1 avg visits 9/21 to 2.7 9/26)
- 20 schools with cases
- 56 students
- 23 saff

New Building

 - Property Line
