Preschool Program Recommendations for 2021-2022

Goal: Reinstate RCCSD preschool program to provide foundational skills and readiness for Kindergarten while ensuring fiscal sustainability

Recommendations:

- Half-day sessions with 18 students in morning and afternoon cohorts
 - Serve more students and as many Reading students as possible
 - Developmentally appropriate instructional time (lunch, rest, additional recess removed)
- Prioritize student enrollment as follows:
 - Reading 4 year olds
 - Reading 3 year olds
 - Staff 4 year olds
 - Staff 3 year olds
 - Open Enrollment 4 year olds
 - Open Enrollment 3 year olds

Preschool Program Recommendations for 2021-2022

Goal: Reinstate RCCSD preschool program to provide foundational skills and readiness for Kindergarten while ensuring fiscal sustainability

Recommendations (Continued):

- Increase tuition by \$200 to \$2,750 per year (evaluate tuition annually)
 - \$50 deposit
 - \$300 monthly for 9 months
 - Still in alignment with other regional district preschool programs
 - \$99,000 in revenue to support fully licensed teacher and aide
- · Add students with speech and language needs when possible
 - Supports peer learning within the program
 - Does not require additional staff licensure

Second Semester Planning

- 1. Maintaining blended learning model for second semester
- 2. Add in-person learning on Wednesday
 - a. Impacts schedules differently across buildings
 - b. Adjustments would be finalized between Dec. 2 and January 19
- 3. Remote learning still an option
 - a. Survey will be sent to remote learning families for commitment to remain remote learning or return to in person learning
 - b. Current in-person learning may shift to remote learning upon request
 - c. Commitment form planned for December 3; response requested by December 8th
