Second Semester Planning

- Delay second semester recommendation to December 2nd Work Session (resolution on the agenda for tonight)
- Based upon information, guidance, pandemic status, and collaborative work with REA:
 - Note: if guidance changes, would revisit to address those changes
- 1. Maintaining blended learning model for second semester
- 2. Add in-person learning on Wednesday
 - a. Impacts schedules differently across buildings
 - b. Adjustments would be finalized between Dec. 2 and January 19
- 3. Remote learning still an option
 - a. Survey will be sent to remote learning families for commitment to remain remote learning or return to in person learning



- b. Current in-person learning may shift to remote learning upon request
- Commitment form planned for December 3; response requested by December 8th

Construction Progress

- **November 3** 11 month walkthrough completed
 - Focus on systems/equipment/items with one year warranty
 - Other outstanding items not reviewed during this process
- November 10 Fiscal review of project completed
 - Outstanding items to address
 - Thurnridge fenceline
 - Noise mitigation chillers
 - Contingency funding remaining
- **December 2** Follow up walkthrough to address punch list and other outstanding items
 - Progress is being made but not at the pace expected
 - Building is open during remote period for contractors to complete items



Fair School Funding Plan

- HB 305 and Companion SB 376
- Continuation of previous Cupp-Patterson work
- Currently, no school district in Ohio is on the state's funding formula
- Three main components:
 - Base Cost
 - State and Local Share
 - Categorical Aid/Targeted Assistance economically disadvantaged, students with disabilities, gifted, ELL, transportation
- Testimony currently being heard from around the state in support of these bills
- Note if approved, impacts not seen by districts immediately and subject to budgetary process at the state level



Winter Athletics

- OHSAA confirmed today that winter seasons are moving forward as planned
- 56% of respondents (superintendents, principals, athletic directors) voted to continue current season schedule dates
- Emphasis on local decision to not participate in contests or suspend seasons
- RCCSD Information
 - No away fans at 7th/8th basketball (CHL)
 - Cheerleaders do not attend away games (CHL)
 - Spectator capacity is 92 in HS gym; participants will receive ticket codes prior to general ticket sales (same as Fall)
 - HS games are single event ticket sales; accommodations will be made for players floating between 9th/JV and JV/Varsity
 - At this time, pep band will not perform (CHL)
 - CHL Wrestling is duals/tri meets only; no individual league tournament (CHL)



Graduation Requirements -Class of 2023 and Beyond

- State law requires students to demonstrate readiness by earning at least two diploma seals
- One must be state defined; state law also requires school districts to develop guidelines for at least one locally defined seal (RCCSD defined below):
 - Community Service 30 or more hours
 - Fine and Performing Arts Earn 2 credits or equivalent (art of music)
 - Student Engagement must meet one of the following:
 - Participate in at least two athletic seasons of any sport
 - Participate in any club for at least two years
- Local seals must be approved by Board of Education
 - Agenda item for December
