

READING BOARD OF EDUCATION BOARD REGULAR SESSION August 4, 2021

The Board of Education of the Reading Community City School District met in Regular Session at Reading Community City School, 810 East Columbia Ave at 5:30 p.m. and streamed live on RCCSD YouTube channel.

Public Participation:

Mr. Christopher Zander – 317 Walnut Street – addressed the Board regarding mask mandates in support of a mask mandate based upon the CDC guidance and ODH recommendations. Mr. Christopher Zander also provided a letter that was sent to the Mason City School Board signed by over 100 physicians.

Ms. Jessica Schaefer – 643 Blanche Ave – stated that the parents should be trusted to make the decision on behalf of their family and beliefs. Ms. Jessica Schaefer believes that masks are a distraction and a layer of frustration. As a mental health professional Ms. Jessica Schaefer states that the suicide levels are at an all time high due to the pandemic.

Ms. Laurie Zirkle – 1233 Fuhrman Rd – in summary Ms. Laurie Z believes that masks are ineffective and don't work and provided the Board a packet of approximately 100 websites pertaining to masks and Covid-19..

Ms. Sarah Barnes – 525 Jefferson – addressed the Board as a parent and requested that the Board send out a parent survey requesting feedback from the community in regards to a mask policy. Ms. Sarah Barnes stated that she believes our constitutional rights are at risk and ask that political views be put aside.

Board Discussion Items

Operational Guidance for 2021-2022 School Year:

Discussion:

School Bus Transportation: The Federal law states that a school bus is considered public transportation and have mask mandates.

Mr. Perdue asked about remote learning. Mr. Jason Enix explained that there was a waiver for the 2020-2021 school year. The current school year, 2021-2022, does not currently have the same waiver. At this current time RCCSD does not have a remote learning option. Families will have to consider other options outside of RCCSD if this is an option they are interested in.

Ms. Amy Thamann, clarified that remote learning is not an option for families currently. However, if a child is quarantined, RCCSD is still working through what options will be available for the 2021-2022 school year.

Mr. Enix has stated that the RCCSD has a responsibility to report positive cases to HCPH.

Ms. Amy Thamann appreciated the information and recommendation provided. Ms. Amy Thamann states that in her opinion we should entrust the parents to make their decision.

Ms. Alycia Bemmes – leaning towards an optional policy as of today with the ability to reevaluate the option to mandate mask. Most important thing is that students are in school.

Mr. Jim Perdue – stated that it might be in the best interest of the Board to wait a little longer to see what will be mandated. Students and staff are the top priority.

Ms. Jason Enix – additional vaccine clinic could be provided if requested.

Mr. Jim Perdue – Requested that the Community receive a simplified/focus summary of implications for not wearing a mask.

Ms. Beth Wernery – It is important for the Board to put personal beliefs aside. We are educators and our top priority is to educate the students.
