Building & Grounds:

Hilltop Baseball/Softball: The bid process was completed on 4/6/2021. Bids were opened at 3pm on 4/6/2021 in the RCCSD Cafetorium. A scope review meeting will be held on 4/15/2021 and board approval is expected on 4/21/2021.

Central Property: Ongoing analysis of property future. Further conversations to continue with the expectations of the future of this property.

Thurnridge Property Line: A meeting was held with Thurnridge residents on 3/20/2021. VSWC, city representatives, Thurnridge residents and school representatives were present for this meeting. After the meeting the current solutions would be to make a minor change to the PDD and move the location of the fence based upon the feedback provided by some of the residents who were present at the 3/20/2021 meeting.
