District Report

Mr. Jason Enix gave a brief overview of the district's COVID-19 recent information. The report highlighted new guidance released from ODH on January 26. This new guidance included discontinuing universal contact tracing and switching to an "outbreak" or cluster model of tracing. School districts will discontinue universal contact tracing and assist health departments with contact tracing as needed. Districts will continue to follow "Mask to Stay/Test to Play". Official new school guidance has not been released from HCPH but an anticipated release is expected on February 4.

Treasurer Burke recognized the success and achievement of Mrs. Colette Lewis and her District Finance Team for being recognized by a recent financial audit of Reading Community City Schools by the Auditor of State's Office that returned a clean audit report for the Fiscal Year 2021. Reading Community City Schools' excellent record keeping has earned the prestigious Auditor of State Award.
