School Spotlight Elementary

Board Committee Updates

Building & Grounds -

- The Hilltop Athletic Complex Dedication has been postponed due to inclement weather. The new dedication date will be announced in the near future.
- Hilltop COPS 2012 Certificate of Participation from 2012-2026. The amount was \$2,000,000 for building improvements at the Hilltop Site. At the time of the agreement, the Hilltop Building was used as the lease to secure the funding. This is similar to collateral in a mortgage loan. Districts are not allowed to take mortgages. In February 2019, the district passed resolution 40-19 to repurpose the unspent balance in the COPS which was about \$945,000 to construct the new Hilltop Facility. In working with the lender, the district passed resolution 242-19 in November 2019 which was the substitution of project facilities underground lease. The balance on the COPs was greater than the value of the new complex being built. The lender requested as time



permitted and funds allowed to invest a \$1,000,000 into the facility to increase the value of the ground lease securing the loan. The district does not have the financial ability to invest further into the facility at this time but it continues to be a goal.

Pet Partners

RCCSD is now approved to bring in volunteer therapy dogs from Pet Partners of Greater Cincinnati to interact with our students and staff. We will be piloting this free program this spring. Therapy Dog Pilot Program is a comprehensive social/emotional program. The program was initiated by the Wellness Committee and studied throughout the 21-22 school year. Notification to the district of approval was provided on 4/19/22. Several classrooms throughout the district will be identified to participate in the pilot program. This will help determine how full implementation might occur in the future.

Summer Learning Program

Superintendent Enix updated the Board about the upcoming Summer Learning Program for all students currently in grades K-8, which is part of the district's Learning Recovery Plan. The purpose of this program is to help students mitigate learning loss and prepare for a successful 2022-2023 school year. The program will begin July 25th through August 5th from 8:30-11:30 a.m. This is a free program funded through ESSER III funds. A registration link will be available to families beginning April 27 through May 6. Families that are interested in participating will be required to complete one registration per student.



RJSH Credit Recovery

The goal of this program is to provide online credit recovery courses on-site for students through APEX learning. The program will begin on June 6 through June 24 from 8:30-11:30 a.m. This is a free program funded through ESSER III funds and students currently in grades 9th through 12th that need credit recovery are eligible. Students eligible for the program will be identified by RJSH staff and enrolled in the program. Additional information will be provided by RJSH.
