School Lunch/Breakfast – Status and Recommend for 22-23

Since March 2020, school lunch and breakfast has been provided free of charge from the USDA. The program is no longer in effect for SY22-23. The cost of food has increased 30% due to inflation. The



district is proposing to increase meal prices to \$2.50 elementary lunch, \$2.75 JH/HS lunch and \$1.50 breakfast for all students. RCCSD costs compared to other districts are still lower and this would be a stair step approach over two years to help families adjust to paying for lunch. All families who are in need are encouraged to complete the Free and Reduced Applications found on Final Forms as well as sharing application for school fee waivers.
