Reading Board of Education Earns OSBA A-Z Gold Award

The Ohio School Boards Association is a statewide organization that provides leadership and support to Ohio's Public School Districts. Its mission is to promote excellence in school board leadership through education, advocacy, and service. Each year they present their A-Z award for school governance. The A-Z Gold Award is the highest level of recognition for school board governance in Ohio. It recognizes school boards that have demonstrated excellence in leadership, communication, and community engagement. To earn this award, school boards must complete a comprehensive assessment process that evaluates their performance in 10 areas of governance, including vision, student achievement, and community relations. This is the 13th consecutive year our Board of Education has been awarded the Gold Award.

State of Ohio Auditor's Award

The Auditor of State's Office presents the Auditor of State Award to local governments and school districts upon the completion of a financial audit. Entities that receive the award meet the criteria of a "clean" audit report. Less than 10% of all school districts earn this award. To receive a clean audit the district must file all financial reports with the AOS within 120 days of the closing of the fiscal year, the audit report does not contain any findings for recovery, no material citations or weaknesses, and the management letter must contain no comments related to ethics referrals, questionable expenditures, lack of timely financial reports, bank reconciliations, findings for recovery, or public meeting or public records



issues. Jennifer Burke accepted the award on behalf of the district. She thanked the Treasurer's Office team, Janie Harris and Kelly Feld, whose dedication to compliance directly attributes to the clean audits. She reminded everyone this is a team award and thanked the Board of Education members, Dr. Davis and his entire team for all their support and commitment to fiscal responsibility. She thanked our prior Treasurer Mrs. Colette Lewis for her work during the first half of last year. Here at Reading, everyone is committed to fiscal responsibility, transparency and compliance. We want to ensure we are good stewards of the funds that we are entrusted with.

READING COMMUNITY CITY SCHOOL DISTRICT BOARD OF EDUCATION RESOLUTION TO ADOPT AN ADMINISTRATIVE SALARY SCHEDULE AND TO PLACE DISTRICT ADMINISTRATORS ON THE NEW SALARY SCHEDULE

WHEREAS, the Reading Community City School District Board of Education ("Board") employs certified school district administrators in various positions such as Principals, Assistant Principals, Coordinators, Directors, etc. pursuant to Ohio Revised Code §3319.01; and

WHEREAS, the Board currently employees these administrators on separate administrative contracts which are not based on a uniform schedule or based on a seniority basis; and WHEREAS, the Treasurer and Superintendent have recommended to the Board that a uniform salary schedule will provide consistency and allow the Board to remain competitive to attract and retain quality administrators in the District; and WHEREAS, upon the Board's adoption of an Administrative Salary Schedule, it will be necessary to place the administrators currently employed by the Board upon said schedule.

NOW, THEREFORE, BE IT RESOLVED by the Reading Community City School District Board of Education as follows: **SECTION I**

The Administrative Salary Schedule, attached hereto as Exhibit A, is hereby adopted as recommended by the Superintendent and Treasurer effective for the 2023-2024 contract year.
