RESOLUTION TO RE-EMPLOY A CERTAIN ADMINISTRATOR WHO HAS ELECTED TO RETIRE AND BE REHIRED BY THE BOARD OF EDUCATION OF THE READING COMMUNITY CITY SCHOOL DISTRICT

WHEREAS, on April 25, 2023, the Board of Education of the Reading Community City School District adopted a Resolution to Initiate Procedures under Ohio Law for the Retirement and Reemployment of Ms. Rebecca Johnson; and



WHEREAS, Ms. Johnson timely elected to retire and be rehired by the Board;
