Safety and Security Updates

Coordinated meetings with local law enforcement

The district has coordinated quarterly safety meetings with local law enforcement and City Leaders. The second meeting was recently held, involving key personnel such as Chief Edens, Chief Owens, Mayor Bemmes, Shawn Riley, HCESC and other district and county representatives.

Emergency Early Dismissal Plan

Following a reunification workshop attended by District Representatives, plans are underway to develop an emergency early dismissal plan. This action is in response to increasing threats and hoaxes in schools nationwide. An updated form for parents detailing early dismissal preferences will be sent out over break.

Turnkey Solutions Contract

Starting December 20th, Turnkey Solutions will be updating safety and security software and hardware in school buildings. This project, co-funded with OFCC, involves testing alarms, intercom systems, and doors.

Emergency Test of School Messenger

A test message was sent to parents in early November to ensure effective communication channels are working properly.

Upcoming Drills

The district plans to conduct more lockdown and evacuation drills, with a full-scale drill scheduled for next fall.

Preschool and Kindergarten Open House

The District successfully held a preschool and kindergarten open house. The event, promoted through social media and with the help of Serendipity, featured model classrooms and allowed families to interact with teachers and administrators. Around 30 families attended. Registration for the next academic year is now available.

High Aims Leadership

The District's Administrative Team participated in the High Aims Leadership Retreat, focusing on artificial intelligence (AI) in education and collaborative initiatives with other districts. The retreat included presentations on AI tools, integration in classrooms, and district-district collaboration projects.



Holiday Programs and Events

A variety of holiday events were organized which included; Holiday Bazaar with over 100 vendors, a Chamber of Commerce holiday dinner, and various school concerts and play. The school also hosted special events for new teacher staff and a Memorial basketball game honoring longtime supporter Mr. Richard Morgan which showcased strong community and school spirit.

Other Updates

The district is preparing for the end-of-semester exams which are on a new schedule allowing the semester to conclude before the holiday break. This change aims to provide a more seamless transition for students and staff into the new semester.
