#### Program of Studies Presentation – Mark Edwards, Assistant Superintendent

Assistant Superintendent Mark Edwards provided an overview of the Program of Studies, highlighting new opportunities to prepare students for college, career, and workforce success. The district is expanding its Pathway Program, helping students align coursework with future goals while introducing over 20 new course opportunities in the coming years.

Several new courses were added to support evolving career fields, including Accelerated Science (7th & 8th grade), Behavioral Health I-III, Cyber Security, Programming, and Principles of Engineering. The district also expanded its Healthcare Pathway with Intro. to Healthcare II and increased adult training opportunities through Great Oaks. Recent additions, such as Art History and Business courses, remain key offerings, along with internships and work-study programs that provide real-world learning experiences.

The district emphasizes leadership and communication skills by requiring formal presentations in every high school course and expanding communication-focused coursework. These efforts and enhanced career pathways aim to ensure that every student graduate with the skills and experiences necessary for success.

Superintendent Dr. Davis reinforced that these curriculum improvements align with the district's mission to provide engaging opportunities and equip students for the future.

## RJSH Update – Mr. Michael Howton

Principal Michael Howton shared updates on key initiatives at Reading Junior-Senior High School (RJSH), emphasizing student engagement, academic growth, and school culture. The school continues to expand career pathways with new electives in STEM, Business, and Healthcare, ensuring students have access to relevant coursework. Additionally, formal presentation skills are now integrated into every class to build confidence in public speaking and critical thinking.

RJSH has implemented Teacher Action Teams focusing on the school environment, student leadership, and PBIS (Positive Behavior Interventions & Supports) to enhance student leadership and school culture. A student and a parent advisory group will also launch in the second semester, giving parents and students a voice in school decisions.



Efforts to strengthen student connections include counselor-led learning sessions that promote engagement and positive relationships with staff. Research shows that students who feel connected perform better academically, making this a top priority.

RJSH remains committed to creating a supportive, high-quality learning environment where students develop the skills and confidence needed for future success.

#### **BOARD DISCUSSION**

#### **Athletic Pay-to-Play Fees**

The Board discussed a proposed increase in athletic pay-to-play fees, which have remained unchanged since 2010. Rising costs in transportation, officiating, and coaching contracts have led to the recommendation of increasing the fee from \$75 per athlete to \$100, with a family cap of \$400. Additionally, students participating in three sports would only be required to pay for two, with the third sport being free. The Board acknowledged the importance of keeping athletics accessible while ensuring program sustainability and will continue reviewing the financial impact before finalizing the decision. No action was taken by the Board. If the Board approves these fee increases, they will be effective in the 2025-2026 school year.

#### **Athletic Season Passes**

The Board discussed adjustments to athletic pass pricing due to increased expenses outpacing revenue. Also, the Cincinnati Hills League (CHL) is requiring an increase in athletic tickets varsity tickets will increase from \$7 to \$10 next year, and JV ticket prices will increase from \$5 to \$7. Proposed changes include raising family annual passes from \$175 to \$200, adding a single-season family pass for \$110, and increasing the adult yearly pass from \$90 to \$105. A new single-season adult pass (\$60) option was also introduced. Student passes remain \$50 annually, with the addition of a single-season student pass at \$30. The Board aims to balance affordability for families while covering operational costs. The Board took no action.

#### **Preschool Tuition Fees**

The Board approved a proposal to adjust SY25/26 preschool tuition rates due to rising instructional and operational costs, including teacher salaries, aides, special education services, and classroom supplies. Preschool tuition has not been increased since 2022. The full-day tuition was recommended to increase from 5,000 to 5,600 per year (550/month + 100 deposit), while the half-day program remained the same at 2,500 per year (245/month + 50 deposit). The Board discussed how this change aligns with past tuition trends and the need to maintain quality early childhood education while ensuring financial sustainability.



#### DISTRICT REPORT

#### 2024-2025 1st Half Bullying Report

Dr. Davis presented the district's first-half bullying report, outlining reported and confirmed incidents in each school. The Elementary School had three reported cases, none confirmed, while RJSH had two reported cases, none confirmed.

Dr. Davis defined bullying and explained that it is when a person or group repeatedly hurts, threatens, or mistreats another person on purpose. Bullying can happen in different ways, including verbal bullying (name-calling, teasing), physical bullying (hitting, pushing), social bullying (spreading rumors, leaving someone out), and cyberbullying (hurtful messages or posts online). For something to be considered bullying, it must be intentional, happen more than once, and cause harm to the person being targeted.

Schools take bullying very seriously because it can make students feel unsafe, anxious, or afraid to come to school. When an incident is reported, staff investigate to determine if it meets the definition of bullying. If it does, the school then takes action, including counseling, discipline, or support for the victim and the person doing the bullying. The goal is to stop bullying and teach students how to treat others with kindness and respect. If you or someone you know is being bullied, it's important to tell a teacher, counselor, or trusted adult so they can help. Everyone deserves to feel safe and supported at school. It is also important to note that even if something doesn't fit the definition of bullying the district can still take disciplinary action to stop the behavior.

#### January/February Professional Development

The district remains committed to ongoing staff development, with recent and upcoming professional learning opportunities. The January 17 in-service focused on formative instructional practices, data-driven decision-making, and classroom engagement strategies. Looking ahead, the February 14 collaborative PD day will follow a conference-style format where RJSH and RES teachers will engage in workshops tailored to teacher expertise and instructional needs. The district's goal is to provide meaningful, teacher-led professional development that enhances instructional effectiveness and student learning.

#### **Business Appreciation Breakfast**

The district is preparing for its second annual Business Appreciation Breakfast on February 20, 2025, from 8:30 to 9:30 a.m. in the main gymnasium. This event recognizes the vital role of local businesses in supporting Reading students and schools. Over 80 business leaders have RSVP'd to attend the breakfast to connect with district leaders, learn about innovative school programs, and explore partnership opportunities. Last year's first event welcomed 30 business representatives.

This initiative, led by Assistant Superintendent Mark Edwards and Career Based Learning Coordinator Todd Schilling, reinforces the district's commitment to building strong community-business relationships that benefit students through mentorships, internships, and real-world learning experiences.
