PRESENTATIONS

Blue Devil Hero - Ms. Amber Stinson

The Board was proud to recognize Ms. Amber Stinson, Elementary Counselor, as the April Blue Devil Hero Award recipient.

Mrs. Stinson has gone above and beyond in supporting students and staff at Reading Elementary. From organizing Career Week and coordinating staff testing encouragements to helping students with challenging behaviors. Her care and positivity make a daily impact. We're so grateful for her contributions to our school community!

BOARD DISCUSSION

U.S. Department of Education

Dr. Davis provided an overview of recent federal developments regarding the potential closure of the U.S. Department of Education. Following President Trump's March 2025 Executive Order, Education Secretary Linda McMahon has been directed to begin phasing out the department "to the maximum extent allowed by law." While full elimination would require Congressional approval and is not imminent, several significant changes are already underway.

Key points from the discussion included:

- Nearly half of the department's workforce has been laid off, and major cuts have been made to the Office for Civil Rights and Federal Student Aid.
- The Trump administration is attempting to transfer programs like student loans and special education to other agencies, such as the Small Business Administration and the Department of Health and Human Services.



- Federal funding plays a critical role in Ohio's Education System, accounting for 11.6% of statewide K-12 public school revenue, approximately \$3.18 billion in 2024. Much of this is targeted toward low-income students (Title I) and students with disabilities (IDEA).
- Closure or downsizing of the department could jeopardize funding for districts like Reading, which rely on these sources for essential student services.
- Statewide, the elimination or reduction of these funds would disproportionately impact urban and high-poverty districts and come at a time when state funding support is declining.

The Board expressed concern over the uncertainty this creates, particularly the threat it poses to Reading's ability to serve students with the greatest needs. They emphasized the importance of advocacy at the state level and continued monitoring of the legislation and executive action as the situation develops.

Legislative Discussion - HB96

Dr. Davis and Treasurer Jennifer Burke shared that the most pressing issue discussed is the significant threat posed by Ohio House Bill 96. Their presentation can be found here. As currently written, HB 96 would undo years of responsible financial planning and educational investment in Reading Schools. Key concerns include:

Elimination of the Fair School Funding Plan (FSFP)

The bill replaces the current, needs-based funding model with a temporary formula based on outdated 2022 data. This disconnects state aid from actual student needs and would cost Reading Schools \$3.1 million over five years, approximately 15% of our annual operating budget.

30% Cap on District Cash Reserves

HB 96 authorizes County Commissioners to roll back property tax rates for one year if a district has more than 30% of its expenditures in reserve, even if those funds were approved by voters. Reading's cash savings are currently 72% of annual operating expenses. This results from long-term planning, one-time federal relief funds, grant efficiency, and fiscal prudence. If this cap goes into effect, Reading Schools would lose an additional \$8.8 million.

Reading Community City Schools has a long-standing reputation for careful financial management. The district went ten years without asking voters for an operating levy until 2022. That levy passed because our community trusted us to be good stewards of their tax dollars, and our financial plan anticipated it lasting ten years before needing to return to the ballot.

Our healthy reserve balance, currently at 72% of prior-year expenditures, results from years of prudent planning, one-time federal relief funds, early-cycle levy strategy, and long-term capital savings. These are not excess funds, but essential safeguards for our financial future.

As Dr. Davis stated, "This is not excess; it is responsible savings. Schools shouldn't be punished for saving responsibly."

If passed, HB 96 could:

- Force the district to return to voters with another operating levy by 2026.
- Require cuts to academic and career-technical programs, including partnerships with workforce initiatives.
- Prevent staffing for the new Career-Technical Education Center.
- It would endanger the district's Aa3 credit rating, increase borrowing costs, and potentially block bond refinancing for taxpayer savings.



• Undermine the strong academic and extracurricular programming that attracts families to Reading and sustains open enrollment.
